RA	Dangerous Goods Fee	Any shipment containing a Dangerous Good shall be charged per instance of UN number on Shippers Declaration. There is no maximum charge per Air Waybill. **DRY ICE IS EXCLUDED FROM THIS FEE**	\$90.00 per U.N. or ID number (Domestic & International) \$50.00 per U.N. or ID number (State of Hawaii)
SC	Screening Fee	Screening Fee	Varies - refer to www.HawaiianAirCargo.com
SR	Storage Charges	Charges that accrue for each day a shipment remains in the HA warehouse after the free allowance period expires. Arrival is defined as check in and notification to the consignee. Free allowance calculation for HA Freight: Complete Arrival at destination on: Free Day Storage Begins SUN MON/TUE WED MON TUE/WED THU TUE WED/THU FRI WED THU/FRI SAT THU FRI/SAT SUN FRI SAT/SUN/MON TUE SAT SUN/MON/TUE WED **If the recognized holiday occurs on any of the free days, delay the beginning of storage by 1 day for each holiday. VL	Valuable Cargo Handling	When a declared value is requested	\$0.75 for each \$100.00 declared in value
VB	Escort Service	When HA escorts a shipment to/from HA's aircraft at the origin and/or destination, including those shipments requiring an escort for the USDA.	\$100.00 per Shipment
ZZ	Miscellaneous Charges Due Carrier	When miscellaneous charges are collected for HA and no other code has been designated	Varies
